Schooner Two Friends

March 14, 1793. Charles McEvers, Jun writes from New York regarding the high prices of produce in the United States resulting from speculation. Since a previous letter, sent on November 18, 1792 (copy inclosed), per the brig Minerva, the price of wheat had gone from 7/6 to 9/3 and flour from 37/ to 46/. Because of this he is unable to execute any of Newton Gordon & Murdock's orders, they having placed ceilings on what they would pay.

The letter is endorsed: per Two Friends. This was a 75 ton schooner built 1791 at Newburyport. The letter was handed directly to the vessel's captain for direct delivery to the addressee.

April 23. Docket notes receipt at Maderia.



NEW YORK TO MADEIRA

Brig Morning Star

April 28, 1793. Charles McEvers, Jun writes to Maderia quoting prices current for Wheat @ 9/3 or 9/6, Fine Flour @ 44/ and Corn @ 5/6. He mentions that he had written on April 15, copy inclosed, per brig Two Friends. He had received their advices per ship Friendship "in a very short passage." He mentions that the War in Europe has had no effect on our produce, which remain high.

Letter is endorsed: per Brig Morning Star. This probably refers to the 164 ton Brigantine Morning Star built in 1765 at Bermuda. This letter was handed directly to the captain of the Morning Star who hand delivered it to Newton Gordon & Murdock.

June 15. Docket notes arrival at Madeira.



NEW YORK TO MADEIRA

Brig Union

November 4, 1793. Charles McEvers Jun. writes again to Maderia. He again reports the rise in price of produce. In March 1793 he had reported Corn 5/ and flour at 44/. Now in November they had risen to 6/ and 46/ respectively. "WE have accounts that there is a very great scarcity of Corn & Flour at Maderia & the Western Islands, particularly the latter place."

Letter is endorsed: per Brig Union. This was probably the 140 ton brig $\underline{\text{Union}}$ built 1792 at Salisbury, Mass. This letter was hand carried by the master of the $\underline{\text{Union}}$ and given directly to the addressee.

December 16. Docket notes arrival at Maderia.

COPENHAGEN TO MADEIRA

Danish India-man Hercules, Capt. V. N. Yorck

November 23, 1795. Letter dated at Copenhagen says, "The bearer of this Capn. Valerius Nielsen Yorck, commander of the Danish Indiaman the Hercules, on his Voyage to Tranquebar* is to touch at your island for the purpose of taking on abt. 400 Pipes of Maderia..." The letter was personally carried to Maderia by Capt. Yorck to obtain the wine.

The letter is endorsed: p the Hercules Capt. V.N. Yorck.

August 7, 1796. Docket notes receipt at Maderia.



^{*}Tranquebar, a seaport town of India, on the Coromandel coast, in the delta of Cavery, 140 miles S.W. of Madras. Tranquebar belonged to Denmark until 1846, when it was ceded by purchase to England.

CHARLESTON, S.C. TO MADEIRA

Schooner Mary Ann, Capt. Henry D. Hill

April 9, 1816. A letter from Thomas Higham introducing Capt. Henry D. Hill of the schooner Mary Ann. Capt. Hill is carrying 25 barrels of rice on his own account, by which he hopes to make an investment in wine. Thos. Higham instructs Newton et al to supply Captain Hill with wine to the extent of the sale of rice and debit him (Higham) with any excess over those proceeds should Capt. Hill wish more wine.

Higham notes that the duties in London on Maderia wine will be reduced by 16ϕ after July 1, so this should present a better market.

The letter is endorsed: favd. by Capt. Hy. D. Hill, who hand carried the letter to Maderia.

January 27, 1824. A copy of a letter written at Calcutta from Palmer & Co. ordering six pipes of the best London Particular Madeira Wine for the mess of H.M. 59th Regiment.

June 14. Letter by Thomas Murdock is appended to the Calcutta letter.

June 25. The brig <u>Dove</u> of the Admiralty packets departed from Falmouth. The London Foreign Office backstamp of 1824 shows the "128" sailing designation. The letter was rated at 2sh.7d., which was computed at the Jan. 1817 rate to Madeira from Falmouth of 1sh.8d. plus the inland rate, London to Falmouth, less 1d. The Act of 1812 rate for a letter conveyed 230-300 miles was 1sh. (London to Falmouth is 270 miles), less one penny left 11d. to be added to the Madeira rate or 1/8d. + 11d. = 2/7d. The paid amount is shown in red.

July 4. A letter docket shows that the <u>Dove</u> arrived at Funchal. She sailed on to arrived at Buenos Aires (River PLate) on August 24. ¶ Letter rated single at 40 centimos due.



Prince Regent was built at F mouth in 1820-21, 233 tons, employed in the packet service 1821-26. She was originally a Post Office packet until transferred to the Admiralty in April 1823.

June 5, 1824. A letter from Thomas Murdock at London. He notes, "The packet has been detained." This was true as the Brazil packets normally left Falmouth around the 15th of the month. Prince Regent didn't leave until June 30.

A letter from Thomas Murdock at London containing a copy of a letter from Copenhagen 31 Augst. 1830, which says, inter alia, "We take the liberty to beg that you will request your House at Madeira to send to our friend Major Rasmussen at St. Croix One Butt best London Particular Madeira Wine - in preference by a direct opportunity with a Dutch vessel, but if no such one should offer, then by a good opportunity to St. Thomas.."

Letter rated, Act of 1828, at 2/7d. per 2-oz., here as a treble letter of 2/7 x 3 = 7sh.9d. shown in red manuscript. Backstamp of the London post office shown F(almouth) 1830. "297" is a sailing designation.





It was rated, Act of 1828, at 2/7d. per $\frac{1}{2}$ -oz., here as a treble letter at $2/7 \times 3 = 7 \text{sh.9d.}$, shown as 7/9 in manuscript. Letter backstamped at the London Foreign Office, "288" is a sailing designation.

April 8. <u>Brig Opossum departed from Falmouth</u>, arrived at Madeira April 16. 80 centimos due. Opossum sailed on to arrive at Rio de Janeiro on May 20.



November 7, 1832. Thomas Murdock writes from London, "The packet sails with the mail of this evening, but I have little more to add to the mass of writing which you will receive under this packet." This was certainly a heavy letter, being rated at 17 x the 2sh.7d. rate per $\frac{1}{2}$ -oz. = £2.3.11, shown in manuscript. Letter backstamped at the Loddon Foreign Office, "267" is a sailing designation.


November 14. Stanmer departed from Falmouth for the Brazils, she arrived at Maderia November 24. 380 centimos due, $9\frac{1}{2}$ times the 40c. rate. The brig Stanmer arrived at Rio de Janeiro December 28.

The Brothers sailed from Falmouth on the 7th and will therefor be with you before the packet..." The normal sailing date of the Brazil Packets at this time was on the 8th, 9th or 10th of the month. This letter went by the Brig Stanmer which did not sail until November 14. No reason for the delay is noted in Howat.



Letter posted at London, Foreign Office backstamp, "285" is a sailing designation. Single rated letter at 2sh.7d. (red manuscript 2/7), the 1828 rate.

November 14. Brazil packet <u>Stanmer</u> sailed from Falmouth, arrived at Madeira Nov. 24. She arrived at Rio de Janeiro on December 28.

Letter rated at Madeira at 40 centimos due, manuscript notation "40".

PHILADELPHIA TO MADEIRA Shio Star, Capt. Griffing

May 8, 1834. A letter from Foster & Co., owners of the ship Star, informing the Madeira wine merchants that they are despatching the Star to Calcutta, and have instructed her captain Griffing to call off Madeira to see if he can obtain a quantity of wine, from 35 to 100 pipes, to be carried aboard her to India and back to Philadelphia.

This letter was handed directly to Captain Griffing for direct delivery to Madeira.

June 3. A letter docket notes receipt of this letter at Madeira. As this letter was handed by Capt. Griffing directly to the addressee, no internal local postage appears on the letter.

Eclipse, 235 tons, built 1819 at Devenport, in service 1823-36. Her commander as of January 22, 1834 was Lt. William Forrester, R.N.

July 30, 1835. A letter datelined at London by Thomas Murdock and endorsed: p Packet. This was a heavy letter containing many enclosures so was rated at 10 times the 1828 rate to Madeira of 2sh.7d. per ½-oz. 2/7 x 10 = £ 1.5.10d., shown in red manuscript.



"42" is a sailing designation. "August 18. Eclipse arrived at Madeira.

This letter went under cover to New York to meet the sailing of the barque <u>Plymouth</u>, per the notice in the N.Y. <u>Shipping & Commercial List</u>: Vessels up for Foreign Ports: MADEIRA, Barque Plymouth, Perkins, 25th June...Foster & Nickerson.

The Plymouth cleared the Port of New York on June 24, sailed on the 25th.

"Mr. Marsh proceeds to Madeira in this vessel and will no doubt give you all the news from this region."

November 9. R.M.S.P. Tay departed on schedule from Southampton.
